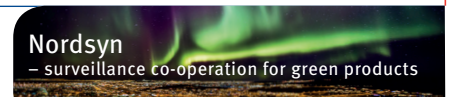




Content of Technical Documentation to provide to market surveillance authorities

Household dishwashers are covered by ecodesign requirements according to Regulation (EU) No 1016/2010 and requirements by energy labelling according to Regulation (EU) No 1059/2010. The requirements only apply to household dishwashers as described in Article 1 and 2 of the above mentioned regulations. The documentation shall be produced before the domestic dishwasher is placed on the market. The technical documentation shall be sufficient to enable assessment of the conformity of the domestic dishwasher with the requirements. In this respect it is important that test reports are included in the technical documentation.

Household dishwashers

This guide presents the technical documentation that you have to provide if the market surveillance authorities ask for it. There are however other information requirements and requirements on web-information that you always need to fulfil according to the regulations.

Technical documentation for household dishwashers

Demands	How to comply
Name and address of supplier	Company name and complete address.
General description	Description of the model so that it is easily identified (model name and number, size etc.) - and a list of equivalent product models, if relevant.
List of applied standards	Applied measurement standards (harmonised standards and/or other standards).
Identification and signature of the person empowered to bind the supplier	Name and signature of the person responsible for the product.
Calculation results and information Apply to both ecodesign and energy labelling	<p>Results of calculations A copy of the calculations including energy efficiency index, cleaning efficiency index, and drying efficiency index etc. carried out in accordance with Regulation 1016/2010/EU Annex II, or delegated Regulation 1059/2010/EU Annex VII.</p> <p>Models where the data is obtained from another product model Where the information in the technical documentation is based on calculation or extrapolation from another dishwasher model, details of such calculations or extrapolations shall be included.</p> <p>Furthermore a list of all other equivalent dishwashers where the information is obtained on the same basis shall be provided.</p>

← The energy efficient index shall not exceed the limits for the declared energy class set in Regulation 1059/2010/EU Annex VI.
← Be aware of the rounding rules.

COMMISSION DELEGATED REGULATION 1059/2010 of 28 September 2010 supplementing Directive 2010/30/EU of the European Parliament and of the Council with regard to energy labelling of household dishwashers

Equivalent product means a product model placed on the market with the same technical and performance characteristics, as another product placed on the market under a different commercial name by the same manufacturer.
